EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-1282

Reversed & Remanded

PROCEDURAL HISTORY AND FINDINGS OF FACT: On December 27, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant had failed to provide information to the Department and was therefore ineligible for unemployment insurance benefits for the weeks of November 27, 2022 through December 10, 2022 (weeks 48-22 through 49-22) and until the reason for the denial ended (decision # 614348). On January 17, 2023, decision # 614348 became final without claimant having filed a request for hearing. On October 4, 2023, claimant filed a late request for hearing on decision # 614348.

ALJ Kangas considered claimant's request, and on October 13, 2023 issued Order No. 23-UI-238367, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by October 27, 2023. On October 31, 2023, claimant filed a late response to the appellant questionnaire and a timely application for review of Order No. 23-UI-238367 with the Employment Appeals Board (EAB). On November 30, 2023, ALJ Kangas mailed a letter stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late. This matter comes before EAB based upon claimant's October 31, 2023 application for review of Order No. 23-UI-238367.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's response to the appellant questionnaire, marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

CONCLUSIONS AND REASONS: Order No. 23-UI-238367 is set aside and this matter remanded for a hearing on whether claimant's late request for hearing on decision # 614348 should be allowed and, if so, the merits of that decision.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist. Under OAR 471-040-0010(1)(b)(A), "good cause" does not include "[f]ailure to receive a document due to not notifying the Employment Department or Office of Administrative Hearings of an updated address while the person is claiming benefits or if the person knows, or reasonably should know, of a pending appeal."

The request for hearing on decision # 614348 was due by January 17, 2023. Because claimant did not file their request for hearing until October 4, 2023, the request was late. On their appellant questionnaire response, claimant indicated that they did not receive a copy of decision # 614348, explaining, "I was in the process of moving and my mail was not being forwarded correctly. I also had COVID so it took a while to fix the problem in person." EAB Exhibit 1 at 1–2. If claimant did not receive decision # 614348, they may have had filed the late request for hearing due to factors beyond their reasonable control. However, further inquiry is necessary to determine whether claimant's late request for hearing should be allowed.

On remand, the ALJ should develop the record to show when claimant moved; when, if at all, they updated the Department with their new address; whether claimant was claiming benefits or knew or had reason to know of a pending appeal at the time that decision # 614348 was mailed; and whether any other factors contributed to claimant's failure to receive decision # 614348. Additionally, the ALJ should inquire as to when and how claimant learned about decision # 614348 and what prompted claimant to file the request for hearing when they did.

Order No. 23-UI-238367 therefore is reversed, and this matter remanded for a hearing on whether claimant's late request for hearing should be allowed and, if so, the merits of decision # 614348.

DECISION: Order No. 23-UI-238367 is set aside, and this matter remanded for further proceedings consistent with this order.
