

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-1294**

*Affirmed*  
*Late Request for Hearing Dismissed*

**PROCEDURAL HISTORY:** On June 26, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective April 30, 2023 (decision # 103415). On July 17, 2023, decision # 103415 became final without claimant having filed a request for hearing. On August 18, 2023, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on November 9, 2023, issued Order No. 23-UI-240894, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by November 23, 2023. On November 27, 2023, claimant filed a late response to the appellant questionnaire and a timely application for review of Order No. 23-UI-240894 with the Employment Appeals Board (EAB).

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's response to the appellant questionnaire, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**FINDINGS OF FACT:** (1) On June 26, 2023, the Department mailed decision # 103415 to claimant at their mailing address of record on file with the Department. Decision # 103415 stated, "You have the right to appeal this decision if you do not believe it is correct. Your request for appeal must be received no later than July 17, 2023." Exhibit 1 at 2.

(2) According to the Department's records, on June 29, 2023, claimant called the Department, and a representative discussed the substance of decision # 103415 and claimant's "appeal rights."<sup>1</sup> The

Department's records do not contain any notation of claimant requesting a hearing on decision # 103415 prior to August 18, 2023, but note that claimant had other pending issues on their claim in June 2023 involving reemployment and identity verification requirements.<sup>2</sup>

**CONCLUSIONS AND REASONS:** Claimant's late request for hearing is dismissed.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

To be timely, a request for hearing on decision # 103415 must have been filed by July 17, 2023. Because claimant filed their request for hearing on August 18, 2023, the request was late. Claimant stated in their request for hearing, "I previously requested an appeal and missed my appt as I returned to work." Exhibit 2 at 1. The record does not show any previous request for hearing on decision # 103415, and suggests that claimant may have been referring to missing deadlines to attend a reemployment interview and to complete identity verification at a WorkSource office, issues which were also affecting the claim at the time but were unrelated to decision # 103415. Claimant filed a response to the appellant questionnaire with their application for review but did not elaborate on their earlier statement or otherwise provide information to explain why the request for hearing was late. Accordingly, claimant has not shown good cause to extend the deadline for timely filing, and claimant's late request for hearing is dismissed.

**DECISION:** Order No. 23-UI-240894 is affirmed.
