EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-1307

Affirmed Late Request for Hearing Allowed, Ineligible for Pandemic Unemployment Assistance Overpayment and Penalties

PROCEDURAL HISTORY: On September 27, 2022, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to PUA benefits effective February 2, 2020. On October 14, 2022, the Department served notice of an administrative decision based in part on the September 27, 2022, PUA determination, concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain benefits, and assessing an overpayment of \$15,170 in PUA and \$20,400 in Federal Pandemic Unemployment Compensation (FPUC) benefits that claimant was required to repay, and a \$5,335.50 monetary penalty. On October 17, 2022, the September 27, 2022, PUA determination became final without claimant having filed a request for hearing.

On November 3, 2022, claimant filed a late request for hearing on the September 27, 2022, PUA determination and a timely request for hearing on the October 14, 2022, overpayment decision. On November 9, 2023, ALJ Wardlow conducted hearings regarding both administrative decisions. On November 15, 2023, ALJ Wardlow issued Order No. 23-UI-241210, allowing claimant's late request for hearing on the September 27, 2022, PUA determination and affirming that decision by concluding that claimant was not eligible for PUA benefits from March 8, 2020, through August 28, 2021 (weeks 11-20 through 34-21). On November 17, 2023, ALJ Wardlow issued Order No. 23-UI-241441, affirming the October 14, 2022, overpayment decision. On December 1, 2023, claimant filed applications for review of Orders No. 23-UI-241210 and 23-UI-241441 with the Employment Appeals Board (EAB).

Order No. 23-UI-241441 did not explicitly conclude that claimant remained liable for the \$5,335.50 monetary penalty assessed by the October 14, 2022, overpayment decision. However, the issue of the monetary penalty was fully addressed at hearing. Transcript at 47–48. Further, the order's findings of fact found that claimant had been assessed the monetary penalty, stated that the October 14, 2022, overpayment decision was affirmed, and did not conclude that claimant should not be liable for the monetary penalty. Order No. 23-UI-241441 at 3, 7. As such, the omission of the monetary penalty from the order's conclusion is presumed to be scrivener's error, and its assessment stands.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-241210 and 23-UI-241441. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-1308 and 2023-EAB-1307).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 23-UI-241210 and 23-UI-241441 are affirmed.
