# EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-1309

Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On October 5, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work from September 17 through September 30, 2023, and was denied benefits for that period and until the reason for the denial ended (decision # 101832). On October 15, 2023, claimant filed a timely request for hearing. On October 24, 2023, the Department served notice of an administrative decision replacing and invalidating decision # 101832, concluding that claimant was not available for work from September 24 through October 7, 2023, and was denied benefits for that period and until the reason for the denial ended (decision # 120234). Claimant's October 15, 2023, request for hearing on decision # 101832 was applied to decision # 120234. On November 1, 2023, ALJ Sachet-Rung conducted a hearing, and on November 2, 2023, issued Order No. 23-UI-240233, affirming decision # 120234. On November 22, 2023, Order No. 23-UI-240233 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On December 3, 2023, claimant filed a late application for review of Order No. 23-UI-240233 with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement claimant included with her application for review and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**FINDING OF FACT:** (1) Order No. 23-UI-240233, mailed to claimant on November 2, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-240233 at 3. Order No. 23-UI-240233 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before November 22, 2023, to be timely."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 23-UI-240233 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-240233 was due November 22, 2023. Because claimant did not file their application for review until December 3, 2023, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented her from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and her late application for review is dismissed.

**DECISION:** The application for review filed December 3, 2023, is dismissed. Order No. 23-UI-240233 remains undisturbed.
