EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-1332

Affirmed Overpayment Assessed

PROCEDURAL HISTORY: On May 12, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received \$4,147 in Regular Unemployment Insurance (Regular UI) and \$3,300 in Federal Pandemic Unemployment Compensation (FPUC) benefits to which he was not entitled and must repay (decision # 125831). Claimant filed a timely request for hearing. On November 28, 2023, ALJ Adamson conducted a hearing, and on December 1, 2023 issued Order No. 23-UI-242442, modifying decision # 125831 by concluding that claimant received \$4,147 in Regular UI benefits that he must repay, and also was overpaid FPUC benefits, but that the Department had waived repayment of the FPUC benefits. On December 14, 2023, claimant filed an application for review of Order No. 23-UI-242442 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: In written argument, claimant asked for this case to be dismissed because his request for a waiver had already been approved. However, the record shows only that the Department granted claimant's request for a waiver of the FPUC benefits he was overpaid. The record does not show that claimant requested a waiver of the \$4,147 in Regular UI benefits he was overpaid. However, Department records show that on December 1, 2023, the Department mailed claimant a state waiver form at his request.¹

To make a request for waiver of the \$4,147 in Regular UI benefits he was overpaid, claimant may also call 503-947-1995 or email OED_Overpayment_unit@employ.oregon.gov. To access a State UI Overpayment Waiver application, claimant may go online to https://unemployment.oregon.gov/overpayment and click the link for "State UI Overpayment Waiver".

¹ EAB has taken notice of this fact, which is contained in Employment Department records. OAR 471-041-0090(1) (May 13, 2019). Any party that objects to our taking notice of this information must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the noticed fact will remain in the record.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-242442 is affirmed.
