**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-1349**

*Affirmed*  
*Request to Reopen Denied*

**PROCEDURAL HISTORY:** On April 21, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant owed an outstanding unemployment debt to the State of Wisconsin in the amount of \$1,641 that the Department was required to deduct from any future benefits payable on claimant's claim in Oregon, that all amounts deducted would be forwarded to Wisconsin to be applied to the overpayment, and that the deduction would be taken from claimant's weekly benefits at his full weekly benefit eligibility. Claimant filed a timely request for hearing. On May 31, 2023, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for June 20, 2023. On June 20, 2023, claimant failed to appear at the hearing, and on June 22, 2023, ALJ Monroe issued Order No. 23-UI-228447, dismissing claimant's request for hearing due to his failure to appear.

On June 28, 2023, claimant filed a timely request to reopen the June 20, 2023, hearing. On November 3, 2023, OAH served notice of a hearing scheduled for November 14, 2023, on whether to grant claimant's request to reopen the hearing and, if so, the merits of the April 21, 2023, administrative decision. On November 14, 2023, ALJ Monroe conducted the hearing, and on December 12, 2023, issued Order No. 23-UI-243177, denying claimant's request to reopen the June 20, 2023, hearing, leaving Order No. 23-UI-228447 and the April 21, 2023, administrative decision undisturbed. On December 16, 2023, claimant filed an application for review of Order No. 23-UI-243177 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 23-UI-243177 is affirmed.
