Affirmed
Late Requests for Hearing Dismissed

PROCEDURAL HISTORY: On December 22, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed without good cause to accept suitable work when offered and therefore was denied benefits beginning May 17, 2020 (decision # 121400). Also on December 22, 2020, the Department served notice of an administrative decision concluding that claimant was denied benefits for the period of May 10 through September 19, 2020, because claimant did not actively seek work during that period (decision # 125510). On January 11, 2021, decisions # 121400 and 125510 became final without claimant having filed a request for hearing.

On April 2, 2022, claimant filed late requests for hearing on decisions # 121400 and 125510. ALJ Kangas considered the requests, and on July 11, 2022, issued Orders No. 22-UI-197884 and 22-UI-197890, dismissing the requests as late, subject to claimant's right to renew the requests by responding to an appellant questionnaire by July 25, 2022. Claimant filed a timely response to the appellant questionnaire. On October 19, 2022, the Office of Administrative Hearings (OAH) mailed letters stating that Orders No. 22-UI-197884 and 22-UI-197890 were cancelled and vacated, and that hearings would be scheduled to determine whether to allow claimant's late requests for hearing and, if so, the merits of decisions # 121400 and 125510.

On December 13, 2023, ALJ Lucas conducted hearings, and on December 15, 2023, issued Orders No. 23-UI-243604 and 23-UI-243602, dismissing claimant's late requests for hearing as without good cause, leaving decisions # 121400 and 125510 undisturbed. On December 19, 2023, claimant filed applications for review of Orders No. 23-UI-243604 and 23-UI-243602 with the Employment Appeals Board (EAB). Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-243604 and 23-UI-243602. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-1354 and 2023-EAB-1353).

EAB reviewed both hearing records. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 23-UI-243604 and 23-UI-243602 are affirmed.
