

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-1355

Affirmed
Regular UI Overpayment Assessed
FPUC Overpayment Not Assessed

PROCEDURAL HISTORY: On October 18, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was overpaid \$600 in Federal Pandemic Unemployment Compensation (FPUC) and \$320 in Regular Unemployment Insurance (Regular UI) benefits that he must repay by deduction from future benefits payable (decision # 105619). Claimant filed a timely request for hearing. On November 30, 2023, ALJ Nyberg conducted a hearing, and on December 8, 2023 issued Order No. 23-UI-243022, modifying decision # 105619 by that claimant was overpaid \$600 in FPUC and \$320 in Regular UI benefits, but only required to repay the \$320 in Regular UI benefits because the Department had waived repayment of the \$600 in FPUC benefits. On December 19, 2023, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-243022 is affirmed.
