

**EMPLOYMENT APPEALS BOARD DECISION**  
**2024-EAB-0013**

*Affirmed*  
*Late Requests for Hearing Dismissed*

**PROCEDURAL HISTORY:** On December 31, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work from November 22 through December 19, 2020 (weeks 48-20 through 51-20) and was not eligible for benefits for those weeks and until the reason for the denial ended (decision # 91626). Also on December 31, 2020, the Department served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective December 13, 2020 (decision # 90620). On January 20, 2021, decisions # 91626 and 90620 became final without claimant having filed a request for hearing for either decision. On February 9, 2022, claimant filed a late request for hearings on decisions # 91626 and 90620.

On December 4, 2023, ALJ Adamson conducted a hearing on whether to allow claimant's late requests for hearing decisions # 91626 and 90620. On December 5, 2023, ALJ Adamson issued Order No. 23-UI-242571, dismissing claimant's request for hearing on decision # 91626 as late without good cause, leaving decision # 91626 undisturbed. Also on December 5, 2023, ALJ Adamson issued Order No. 23-UI-242572, dismissing claimant's request for hearing on decision # 90620 as late without good cause, leaving decision # 90620 undisturbed. On December 21, 2023, claimant filed applications for review of Orders No. 23-UI-242571 and 23-UI-242572 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-242571 and 23-UI-242572. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2024-EAB-0012 and 2024-EAB-0013).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 23-UI-242571 and 23-UI-242572 are affirmed.
