**EMPLOYMENT APPEALS BOARD DECISION**  
**2024-EAB-0027**

*Affirmed*  
*Ineligible Weeks 27-21, 30-21, 32-21, 34-21, 38-21, 40-21, and 42-21*  
*Disqualification Beginning Week 42-21*

**PROCEDURAL HISTORY:** On November 18, 2021, the Oregon Employment Department (the Department) served notice of nine administrative decisions concluding that claimant was denied benefits for the weeks of July 4 through 10, 2021 (decision # 94743), July 25 through 31, 2021 (decision # 101722), August 8 through 14, 2021 (decision # 113831), August 22 through 28, 2021 (decision # 114859), September 19 through 25, 2021 (decisions # 120401 and 90828), October 3 through 9, 2021 (decisions # 122359 and 81828), and October 17 through 23, 2021 (decision # 123651) because claimant was not available for work during those weeks. Also on November 18, 2021, the Department served notice of an administrative decision concluding that claimant was denied benefits beginning October 17, 2021 because he quit working for the employer without good cause (decision # 93439). Claimant filed a timely request for hearing on all ten administrative decisions.

On December 8, 2023, ALJ Janzen conducted hearings and issued Orders No. 23-UI-243038, 23-UI-243032, 23-UI-243035, 23-UI-243024, 23-UI-243029, 23-UI-243030, 23-UI-243036, 23-UI-243037, 23-UI-243034, and 23-UI-243039, affirming decisions # 94743, 101722, 113831, 114859, 120401, 90828, 122359, 81828, 123651, and 93439. On December 22, 2023, claimant filed applications for review of Orders No. 23-UI-243038, 23-UI-243032, 23-UI-243035, 23-UI-243024, 23-UI-243029, 23-UI-243030, 23-UI-243036, 23-UI-243037, 23-UI-243034, and 23-UI-243039 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-243038, 23-UI-243032, 23-UI-243035, 23-UI-243024, 23-UI-243029, 23-UI-243030, 23-UI-243036, 23-UI-243037, 23-UI-243034, and 23-UI-243039. For case-tracking purposes, this decision is being issued in replicate (EAB Decisions 2024-EAB-0026, 2024-EAB-0021, 2024-EAB-0023, 2024-EAB-0018, 2024-EAB-0019, 2024-EAB-0020, 2024-EAB-0024, 2024-EAB-0025, 2024-EAB-0022, and 2024-EAB-0027).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 23-UI-243038, 23-UI-243032, 23-UI-243035, 23-UI-243024, 23-UI-243029, 23-UI-243030, 23-UI-243036, 23-UI-243037, 23-UI-243034, and 23-UI-243039 are affirmed.
