EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0028

Late Request for Reconsideration Dismissed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On February 19, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective March 15, 2020 (decision # 95127). On March 11, 2021, decision # 95127 became final without claimant having filed a request for hearing. On April 5, 2022, claimant filed a late request for hearing. On December 6, 2023, ALJ Goodrich conducted a hearing and issued Order No. 23-UI-242787, dismissing the request as late without good cause, leaving decision # 95127 undisturbed. On December 25, 2023, claimant filed an application for review with the Employment Appeals Board (EAB). On January 19, 2024, EAB issued EAB Decision 2024-UI-0028, affirming Order No. 23-UI-242787. On February 26, 2024, claimant filed a late request for reconsideration of EAB Decision 2024-UI-0028 with EAB. This decision is issued pursuant to EAB's authority under ORS 657.290(3).

CONCLUSIONS AND REASONS: Claimant's late request for reconsideration is dismissed.

ORS 657.290(3) authorizes the Employment Appeals Board to reconsider any previous decision of the Employment Appeals Board, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment Department practice." OAR 471-041-0145(1) (May 13, 2019). The request is subject to dismissal unless it includes a statement that a copy was provided to the other parties, and is filed on or before the 20th day after the decision sought to be reconsidered was mailed. OAR 471-041-0145(2).

EAB Decision 2024-EAB-0028 was mailed to the parties on January 19, 2024. Claimant's request for reconsideration was filed February 26, 2024, more than 20 days after the decision sought to be

reconsidered was mailed, and was therefore late. Additionally, claimant's request for reconsideration did not include a statement that a copy was provided to the other parties. The request for reconsideration is therefore dismissed pursuant to OAR 471-041-0145(2).

DECISION: Claimant's late request for reconsideration is dismissed. EAB Decision 2024-EAB-0028 remains undisturbed.
