EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0029

Late Application for Review Dismissed

PROCEDURAL HISTORY: On June 28, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant had failed to provide information to the Department and was therefore not eligible for unemployment insurance benefits for the weeks including April 3 through April 9, 2022 (week 14-22) and until claimant provided the requested information (decision # 592867). On July 18, 2022, decision # 592867 became final without claimant having filed a request for hearing. On October 18, 2023, claimant filed a late request for hearing on decision # 592867. ALJ Kangas considered claimant's request, and on November 22, 2023, issued Amended Order No. 23-UI-241793, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by December 6, 2023. On December 12, 2023, Amended Order No. 23-UI-241793 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On December 18, 2023, claimant filed a late response to the appellant questionnaire with the Office of Administrative Hearings and a late application for review of Amended Order No. 23-UI-241793 with EAB. On December 20, 2023, ALJ Kangas mailed a letter to claimant stating that because the response to the appellant questionnaire was late, it would not be considered, and another order would not be issued. This matter comes before EAB based upon claimant's December 18, 2023, late application for review.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's response to the appellant questionnaire and a written argument submitted with claimant's application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Amended Order No. 23-UI-241793, mailed to claimant on November 22, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Amended Order No. 23-UI-241793 at 2. Amended Order No. 23-UI-241793 also stated on its Certificate of Mailing,

"Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than December 12, 2023."

CONCLUSIONS AND REASONS: Claimant's late application for review of Amended Order No. 23-UI-241793 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Amended Order No. 23-UI-241793 was due by December 12, 2023. Because claimant did not file their application for review until December 18, 2023, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review on time. EAB Exhibit 1. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed December 18, 2023, is dismissed. Order No. 23-UI-241793 remains undisturbed.
