EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0049

Affirmed Request to Reopen Allowed Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On February 19, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant willfully made a misrepresentation to obtain benefits, and assessing an overpayment of \$755 in regular unemployment insurance (regular UI) benefits, \$151 in Pandemic Emergency Unemployment Compensation (PEUC) benefits, and \$3,600 in Federal Pandemic Unemployment Compensation (FPUC) benefits that claimant was required to repay to the Department, a \$113.25 monetary penalty, and a five-week penalty disqualification from future benefits. On March 11, 2021, the February 19, 2021 administrative decision became final without claimant having filed a request for hearing. On May 15, 2023, claimant filed a late request for hearing on the February 19, 2021 administrative decision. ALJ Kangas considered claimant's request, and on September 21, 2023 issued Order No. 23-UI-236480, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by October 5, 2023. On September 27, 2023, claimant filed a timely response to the appellant questionnaire. On October 3, 2023, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 23-UI-236480 was vacated and that a hearing would be scheduled to determine whether claimant had good cause to file the late request for hearing and, if so, the merits of the February 19, 2021 administrative decision. Also on October 3, 2023, OAH served a notice of hearing scheduled for October 18, 2023 at 9:30 a.m. On October 18, 2023, claimant failed to appear for the hearing, and ALJ Lucas issued Order No. 23-UI-239614, dismissing the hearing request due to claimant's failure to appear, and leaving the February 19, 2021 administrative decision undisturbed.

On November 4, 2023, claimant filed a timely request to reopen the hearing. On December 20, 2023, ALJ Nyberg conducted a hearing, and on December 21, 2023 issued Order No. 23-UI-243971, allowing claimant's request to reopen the October 18, 2023 hearing and cancelling Order No. 23-UI-239614,¹ but

¹ Order No. 23-UI-243971 stated that the hearing order it was cancelling was Order No. 23-UI-236480. *See* Order No. 23-UI-243971 at 5. However, as Order No. 23-UI-236480 was ALJ Kangas's direct review dismissal order that had already been cancelled, it is presumed this was a typographical error and the order intended to reference Order No. 23-UI-239614, the order that dismissed claimant's hearing request due to his failure to appear at the October 18, 2023 hearing.

re-dismissing claimant's request for hearing on the February 19, 2021 administrative decision as late without good cause and leaving the February 19, 2021 administrative decision undisturbed. On January 3, 2024, claimant filed an application for review of Order No. 23-UI-243971 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant did not declare that he provided a copy of his argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented him from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-243971 is affirmed.
