

EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0053

Late Application for Review Dismissed

PROCEDURAL HISTORY: On September 8, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits for the week of August 21 through August 27, 2022, and until claimant registered for work following the Department's rules. On September 28, 2022, the September 8, 2022, administrative decision became final without claimant having filed a timely request for hearing. On March 16, 2023, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on July 28, 2023, issued Order No. 23-UI-231820, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellate questionnaire by August 11, 2023. On August 8, 2023, claimant filed a timely response to the appellant questionnaire.

On August 29, 2023, the Office of Administrative Hearings (OAH) mailed a letter stating that based on claimant's appellant questionnaire response, Order No. 23-UI-231820 was cancelled and vacated, and a hearing would be scheduled on whether to allow claimant's late request for hearing and, if so, the merits of the September 8, 2022, administrative decision. On August 31, 2023, OAH served notice that the hearing was scheduled for September 14, 2023. On September 14, 2023, claimant failed to appear at the hearing, and ALJ Chiller issued Order No. 23-UI-235915, dismissing claimant's request for hearing for failure to appear, leaving the September 8, 2022, administrative decision undisturbed.

On October 3, 2023, claimant filed a timely request to reopen the September 14, 2023, hearing. ALJ Kangas considered claimant's request to reopen, and on November 30, 2023, issued Order No. 23-UI-242339, denying the request and leaving Order No. 23-UI-235915 undisturbed. On December 20, 2023, Order No. 23-UI-242339 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On January 4, 2024, claimant filed a late application for review with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement claimant included with their application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of

our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

FINDING OF FACT: Order No. 23-UI-242339, mailed to claimant on November 30, 2023, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed.” Order No. 23-UI-242339 at 3. Order No. 23-UI-242339 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before December 20, 2023, to be timely.”

CONCLUSIONS AND REASONS: Claimant’s late application for review of Order No. 23-UI-242339 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-242339 was due December 20, 2023. Because claimant did not file their application for review until January 4, 2024, the application for review was late. Claimant provided a written statement with the application for review. EAB Exhibit 1. However, claimant’s written statement did not describe the circumstances that prevented claimant from filing the application for review on time. EAB Exhibit 1. Accordingly, claimant did not show good cause for the late application for review, and claimant’s late application for review is dismissed.

DECISION: The application for review filed January 4, 2024, is dismissed. Order No. 23-UI-242339 remains undisturbed.
