EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0064

Late Application for Review Dismissed

PROCEDURAL HISTORY: On July 13, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received \$785 in regular unemployment insurance (regular UI) and \$1,500 in Federal Pandemic Unemployment Compensation (FPUC) benefits to which they were not entitled and must repay (decision # 164033). Claimant filed a timely request for hearing. On December 18, 2023, ALJ Fraser conducted a hearing and issued Order No. 23-UI-243669, affirming decision # 164033. On January 8, 2024, Order No. 23-UI-243669 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On January 10, 2024, claimant filed a late application for review with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's application for review and written statement, and the envelope containing these documents, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDINGS OF FACT: (1) Order No. 23-UI-243669, mailed to claimant on December 18, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-243669 at 4. Order No. 23-UI-243669 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before January 8, 2024 to be timely."

(2) Claimant filed her application for review by mail. The postmark date affixed to the envelope in which the application was mailed is January 10, 2024. EAB Exhibit 1 at 4.

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 23-UI-243669 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-243669 was due January 8, 2024. The filing date for an application for review filed by mail is the postmark date affixed to the envelope in which the application was mailed. OAR 471-041-0065(1)(b) (May 13, 2019). The postmark date on the envelope in which claimant mailed her application for review was January 10, 2024; that date is therefore the filing date. Because claimant did not file their application for review until January 10, 2024, the application for review was late.

Claimant provided a written statement with the application for review. However, claimant's written statement explained only why she disagreed with the order under review and did not describe circumstances preventing her from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and her late application for review is dismissed.

DECISION: The application for review filed January 10, 2024 is dismissed. Order No. 23-UI-243669 remains undisturbed.
