EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0072

Reversed & Remanded

PROCEDURAL HISTORY AND FINDINGS OF FACT: On September 14, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged by the employer for misconduct and disqualified from benefits effective August 6, 2023 (decision # 90156). On October 4, 2023, decision # 90156 became final without claimant having filed a request for hearing. On December 13, 2023, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on December 27, 2023, issued Order No. 23-UI-244215, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by January 10, 2024. On January 12, 2024, claimant filed a late response to the appellant questionnaire and a timely application for review of Order No. 23-UI-244215 with the Employment Appeals Board (EAB).

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's response to the appellant questionnaire, marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

CONCLUSIONS AND REASONS: Order No. 23-UI-244215 is set aside and this matter remanded for a hearing on whether claimant's late request for hearing on decision # 90156 should be allowed and, if so, the merits of that decision.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased

to exist. Under OAR 470-040-0010(1)(b)(B), "good cause" does not include "[n]ot understanding the implications of a decision or notice when it is received."

The request for hearing on decision # 90156 was due by October 4, 2023. Because claimant did not file their request for hearing until December 13, 2023, the request was late. In their appellant questionnaire response, claimant did not indicate when, if ever, they received a copy of decision # 90156, but instead indicated that they had timely requested a hearing on an administrative decision which addressed a separation from a different employer. EAB Exhibit 1 at 1. Claimant also expressed confusion about why decision # 90156 was issued, as they believed that they had claimed benefits only against that employer, not the employer party to this matter. EAB Exhibit 1 at 1. Claimant's response suggests that they may not have received decision # 90156 prior to the timely filing deadline, which may have been a circumstance beyond their reasonable control that led them to file a late request for hearing. However, further information is needed to determine whether claimant's late request for hearing should be allowed.

On remand, the record should be developed to determine when, if ever, claimant received decision # 90156. If claimant received decision # 90156 timely, the record should be developed as to why they did not file a timely request for hearing. If claimant did not receive it timely, or at all, the record should be developed as to what caused them not to timely receive it. Finally, if the record on remand shows that claimant had "good cause" for filing the late request for hearing, inquiry should be made as to whether they did so within a "reasonable time" after the factors which caused the late filing ceased.

Order No. 23-UI-244215 therefore is set aside, and this matter remanded for a hearing on whether claimant's late request for hearing should be allowed and, if so, the merits of decision # 90156.

DECISION: Order No. 23-UI-244215 is set aside, and this matter remanded for further proceedings consistent with this order.

¹ Claimant should note that benefits are not claimed against a specific employer, and that ORS 657.176 often requires the adjudication of more than just the most recent work separation reported on a claim, in order to determine whether any such separations would cause a disqualification from benefits.
