EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0079

Late Application for Review Dismissed

PROCEDURAL HISTORY: On July 20, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and was therefore ineligible to receive unemployment insurance benefits for the week of July 3, 2022, through July 9, 2022 (week 27-22) and until the reason for the denial had ended. On August 9, 2022, the July 20, 2022, administrative decision became final without claimant having filed a request for hearing. On September 19, 2023, claimant filed a late request for hearing. ALJ Kangas considered the request, and on September 26, 2023, issued Order No. 23-UI-236743, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by October 10, 2023. On October 16, 2023, Order No. 23-UI-236743 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On November 15, 2023, claimant filed a late response to the appellant questionnaire and a late application for review with EAB. On January 23, 2024, ALJ Kangas mailed a letter to claimant stating that because the appellant questionnaire response was late, it would not be considered, and another order would not be issued regarding the matter. This matter comes before EAB based upon claimant's November 15, 2023, late application for review of Order No. 23-UI-236743.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement accompanying claimant's late application for review, which is the response to the appellant questionnaire attached to Order No. 23-UI-236743, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 23-UI-236743, mailed to claimant on September 26, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-236743 at 2.

Order No. 23-UI-236743 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than October 16, 2023."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 23-UI-236743 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-236743 was due October 16, 2023. Because claimant did not file their application for review until November 15, 2023, the application for review was late. Claimant provided a written statement with the application for review. In the written statement, claimant discussed why they disagreed with the July 20, 2022, administrative decision and why their request for hearing on that decision was filed late. EAB Exhibit 1 at 2. However, claimant did not describe the circumstances that prevented them from filing the application for review of Order No. 23-UI-236743 on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed November 15, 2023, is dismissed. Order No. 23-UI-236743 remains undisturbed.
