# EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0081

Late Application for Review Dismissed

PROCEDURAL HISTORY: On September 26, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain benefits, and assessing a \$1,464 overpayment that claimant was required to repay to the Department, a \$439.20 monetary penalty, and an eight-week penalty disqualification from future benefits (decision # 193047). On October 17, 2022, decision # 193047 became final without claimant having filed a request for hearing. On October 20, 2023, claimant filed a late request for hearing on decision # 193047. ALJ Kangas considered claimant's request, and on October 26, 2023, issued Order No. 23-UI-239595, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by November 9, 2023. On November 15, 2023, Order No. 23-UI-239595 became final without claimant having filed a response to the appellant questionnaire with the Office Administrative Hearings (OAH) or an application for review with the Employment Appeals Board (EAB). On November 16, 2023, claimant filed a late response to the appellant questionnaire and a late application for review of Order No. 23-UI-239595. On January 24, 2023, ALJ Scott mailed a letter stating that OAH would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late. This matter comes before EAB based upon claimant's November 16, 2023, application for review of Order No. 23-UI-239595.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's application for review with the encoded date stamp showing when the fax was sent, and claimant's response to the appellant questionnaire consisting of the blank questionnaire response form, and paystub copies. This evidence has been marked as EAB Exhibits 1 and 2, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibits 1 and 2 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**FINDING OF FACT:** (1) Order No. 23-UI-239595, mailed to claimant on October 26, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-239595 at 2. Order No. 23-UI-239595 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than November 15, 2023."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 23-UI-239595 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The filing date for an application for review filed by fax is the encoded date on the faxed document. OAR 471-041-0065(1)(d) (May 13, 2019). The encoded date on the application for review claimant faxed to OAH was November 16, 2023; that date is therefore the filing date. EAB Exhibit 1.

The application for review of Order No. 23-UI-239595 was due by November 15, 2023. Because claimant did not file their application for review until November 16, 2023, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented claimant from filing the application for review by the November 15, 2023, deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed November 16, 2023, is dismissed. Order No. 23-UI-239595 remains undisturbed.
