EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0082

Reversed & Remanded

PROCEDURAL HISTORY: On September 29, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide information in accordance with the Department's rules and was therefore ineligible to receive unemployment insurance benefits for the weeks of September 10, 2023, through September 23, 2023 (weeks 37-23 through 38-23) and until the reason for the denial ended (decision # 91151). On October 19, 2023, decision # 91151 became final without claimant having requested a hearing. On November 7, 2023, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on November 20, 2023, issued Order No. 23-UI-241587, dismissing claimant's request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by December 4, 2023. On December 5, 2023, claimant filed a late response to the appellant questionnaire and a timely application for review with the Employment Appeals Board (EAB). On January 26, 2024, ALJ Kangas mailed a letter to claimant stating that because the appellant questionnaire response was late, it would not be considered, and another order would not be issued regarding the matter. This matter comes before EAB based upon claimant's December 5, 2023, application for review of Order No. 23-UI-241587.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement accompanying claimant's application for review, which is the response to the appellant questionnaire attached to Order No. 23-UI-241587, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Decision # 91151, mailed to claimant on September 29, 2023, stated, "You have the right to appeal this decision if you do not believe it is correct. Your request for appeal must be received no later than October 19, 2023." Exhibit 1 at 2.

CONCLUSIONS AND REASONS: Order No. 23-UI-241587 is set aside and the matter remanded for further proceedings to determine whether claimant's late request for hearing should be allowed and, if so, the merits of decision # 91151.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

The deadline to request a hearing on decision # 91151 was October 19, 2023. Because claimant filed their request for hearing on November 7, 2023, the request was late. In the appellant questionnaire, claimant was asked when they received decision # 91151, to which they replied, "12/4/2023." EAB Exhibit 1 at 1. This suggests that claimant did not understand the question and was instead referring to the date they received Order No. 23-UI-241587. It is therefore unclear when claimant received decision # 91151, or if a delay in receiving that decision prevented timely filing. Additionally, claimant wrote in the questionnaire response that they filed their request for hearing by telephone. EAB Exhibit 1 at 1. As the only request for hearing received by the Office of Administrative Hearings (OAH) was filed by claimant online on November 7, 2023, claimant's response suggests that they may have attempted to file an appeal by phone prior to that date. *See* Exhibit 1 at 1. Further development of the record is therefore needed to determine whether claimant's late request for hearing should be allowed.

On remand, inquiry should be made into whether and when claimant received decision # 91151, when and how claimant first attempted to file a request for hearing, and whether factors beyond claimant's reasonable control or an excusable mistake prevented them from timely filing the request. Further, if good cause is found to extend the deadline for timely filing, inquiry should be made into when the factors that prevented timely filing ceased, and whether claimant filed their request for hearing within a "reasonable time" thereafter.

For these reasons, Order No. 23-UI-241587 is set aside and the matter remanded for further proceedings to determine whether claimant's late request for hearing should be allowed and, if so, the merits of decision # 91151.

DECISION: Order No. 23-UI-241587 is set aside, and this matter remanded for further proceedings consistent with this order.
