EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0086

Affirmed
Ineligible Weeks 46-23 through 49-23

PROCEDURAL HISTORY: On November 30, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide information to the Department and was therefore ineligible for unemployment insurance benefits for the weeks of November 12, 2023, through November 25, 2023 (weeks 46-23 through 47-23) and until the reason for the denial had ended (decision # 83208). Also on November 30, 2023, the Department served notice of an administrative decision concluding that claimant had failed to register for work in accordance with the Department's rules and therefore was ineligible for benefits for the week of November 12, 2023, through November 18, 2023 (week 46-23) and until the reason for the denial had ended. Claimant filed timely requests for hearing on decision # 83208 and the November 30, 2023, work registration decision.

On January 11, 2024, ALJ Goodrich conducted a combined hearing on both administrative decisions. On January 12, 2024, ALJ Goodrich issued Order No. 24-UI-245479, modifying decision # 83208 by concluding that claimant failed to provide information to the Department and was therefore ineligible for benefits for weeks 46-23 through 47-23, but had met the requirements, and was therefore eligible for benefits, for the weeks of November 26, 2023 through December 9, 2023 (weeks 48-23 through 49-23).\(^1\) Also On January 12, 2023, ALJ Goodrich issued Order No. 24-UI-245482, modifying the November 30, 2023 work registration decision by concluding that claimant had failed to register for work in accordance with the Department's rules and therefore was ineligible to receive benefits for weeks 46-23 through 49-23. On January 20, 2024, claimant filed applications for review of Orders No. 24-UI-245479 and 24-UI-245482 with the Employment Appeals Board (EAB).

¹ Although Order No. 24-UI-245479 concluded that claimant was eligible for benefits for weeks 48-23 through 49-23, Order No. 24-UI-245482 concluded that claimant was not eligible for benefits for any of the four weeks at issue. While this may seem contradictory, each order addresses a separate eligibility requirement, and *all* of the applicable requirements must be met in order to be eligible for benefits for any given week. Therefore, even though claimant met the ID-verification requirements for weeks 48-23 through 49-23, claimant is still ineligible for benefits for those weeks because she did not meet

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 24-UI-245479 and 24-UI-245482. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2024-EAB-0086 and 2024-EAB-0087).

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's argument to the extent it was based on the record.

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 24-UI-245479 and 24-UI-245482 are affirmed.
