EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0101

Late Application for Review Dismissed

PROCEDURAL HISTORY: On October 31, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged by the employer for misconduct and disqualified from receiving benefits effective August 13, 2023 (decision # 121852). On November 20, 2023, decision # 121852 became final without claimant having filed a request for hearing. On December 7, 2023, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on December 28, 2023, issued Order No. 23-UI-244281, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by January 11, 2024. On January 17, 2024, Order No. 23-UI-244281 became final without claimant having responded to the appellant questionnaire or filed an application for review with the Employment Appeals Board (EAB). On January 23, 2024, claimant filed a late response to the appellant questionnaire and a late application for review with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's response to the appellant questionnaire attached to Order No. 23-UI-244281, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

FINDING OF FACT: (1) Order No. 23-UI-244281, mailed to claimant on December 28, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No 23-UI-244281 at 2. Order No. 23-UI-244281 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than January 17, 2024."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 23-UI-244281 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-244281 was due January 17, 2024. Because claimant did not file his application for review until January 23, 2024, the application for review was late. With his application for review, claimant included his response to the appellant questionnaire attached to Order No. 23-UI-244281. EAB Exhibit 1. However, claimant's appellant questionnaire response did not describe circumstances preventing him from filing the application for review on time. EAB Exhibit 1. Accordingly, claimant did not show good cause for the late application for review, and his late application for review is dismissed.

DECISION: The application for review filed January 23, 2024, is dismissed. Order No. 23-UI-244281 remains undisturbed.
