EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0104

Late Application for Review Dismissed

PROCEDURAL HISTORY: On November 15, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged by the employer for misconduct and disqualified from receiving benefits effective July 2, 2023 (decision # 85936). Claimant filed a timely request for hearing. On December 26 and 27, 2023, ALJ Chiller conducted a hearing, and on January 3, 2024, issued Order No. 24-UI-244665, affirming decision # 85936. On January 24, 2024, claimant filed an application for review of Order No. 24-UI-244665 with the Employment Appeals Board (EAB).

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence claimant's application for review and the envelope in which it was mailed, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 24-UI-244665, mailed to claimant on January 3, 2024, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 24-UI-244665 at 5. Order No. 24-UI-244665 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before January 23, 2024, to be timely."

(2) Claimant filed their application for review of Order No. 24-UI-244665 by mail. The postmark date on the envelope in which claimant mailed their application for review is January 24, 2024. EAB Exhibit 1

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 24-UI-244665 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 24-UI-244665 was due January 23, 2024. The filing date for an application for review filed by mail is the postmark date affixed to the envelope in which the application was mailed. OAR 471-041-0065(1)(b) (May 13, 2019). The postmark date on the envelope in which claimant mailed their application for review is January 24, 2024, which therefore is the filing date. EAB Exhibit 1. Because claimant did not file their application for review until January 24, 2024, the application for review was late. Claimant's application for review did not include a written statement describing circumstances preventing claimant from filing the application for review by the January 23, 2024, deadline. EAB Exhibit 1. Accordingly, claimant did not show good cause for the late application for review, and their late application for review is dismissed.

DECISION: The application for review filed January 24, 2024, is dismissed. Order No. 24-UI-244665 remains undisturbed.
