

EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0107

Affirmed
Late Request for Hearing on Overpayment Decision Dismissed
Request for Waiver of Overpayment Denied

PROCEDURAL HISTORY: On March 12, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant willfully underreported earnings to obtain benefits, received \$17,312 in federal benefits to which she was not entitled and must repay in addition to a \$1,737.60 monetary penalty, and was disqualified for 36 weeks of future benefits (overpayment decision). On April 1, 2021, the overpayment decision became final without claimant having filed a request for hearing. On February 3, 2022, the Department served notice of an administrative decision denying claimant's request for a waiver of the overpayment (decision # 163252). On February 13, 2022, claimant filed a late request for hearing on the overpayment decision and a timely request for hearing on decision # 163252. On December 6 and 21, 2023, ALJ Chiller conducted hearings, on January 8, 2024, issued Orders No. 24-UI-244920 and 24-UI-244922, dismissing claimant's late request for hearing on the overpayment decision and affirming decision # 163252.

On January 25, 2024, claimant filed applications for review of Orders No. 24-UI-244920 and 24-UI-244922 with the Employment Appeals Board (EAB). Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 24-UI-244920 and 24-UI-244922. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2024-EAB-0108 and 2024-EAB-0107).

EAB reviewed both hearing records. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 24-UI-244920 and 24-UI-244922 are affirmed.
