EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0109

Late Request for Hearing Dismissed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On June 5, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective February 5, 2023 (decision # 112508). On June 26, 2023, decision # 112508 became final without claimant having filed a request for hearing. On August 7, 2023, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on December 12, 2023, issued Order No. 23-UI-243257, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by December 26, 2023. On December 19, 2023, claimant filed a timely response to the appellant questionnaire. ALJ Scott considered claimant's response, and on January 19, 2024, issued Order No. 24-UI-246084, re-dismissing claimant's request for hearing as late without a showing of good cause, leaving decision # 112508 undisturbed. On January 26, 2024, claimant filed an application for review of Order No. 24-UI-246084 with EAB.

WRITTEN ARGUMENT: EAB did not consider claimant's written argument submitted with her application for review when reaching this decision because she did not include a statement declaring that she provided a copy of her argument to the opposing party as required by OAR 471-041-0080(2)(a) (May 13, 2019).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 24-UI-246084 is affirmed.
