

**EMPLOYMENT APPEALS BOARD DECISION**  
**2024-EAB-0135**

*Affirmed*  
*No Claim Redetermination*  
*Ineligible for Pandemic Unemployment Assistance Weeks 50-20 through 53-20,*  
*05-21 through 23-21, 25-21, and 27-21 through 35-21*

**PROCEDURAL HISTORY:** On December 4, 2023, the Oregon Employment Department (the Department) served four separate Notices of Determination for Pandemic Unemployment Assistance (PUA), respectively concluding that claimant was not eligible to receive PUA benefits for the periods of December 6, 2020 through December 26, 2020 (weeks 50-20 through 53-20), January 31, 2021 through June 12, 2021 (weeks 05-21 through 23-21), June 20, 2021 through June 26, 2021 (week 25-21), and July 4, 2021 through September 4, 2021 (weeks 27-21 through 35-21). On December 8, 2023, the Department served notice of a Wage and Potential Benefit Report (WPBR) concluding that claimant did not have sufficient hours or earnings in his base year to qualify for a monetarily valid claim for regular unemployment insurance (regular UI) benefits. Claimant filed timely requests for hearing on all five administrative decisions. On January 10, 2024, ALJ Lucas conducted a consolidated hearing on all five administrative decisions. On January 11, 2024, ALJ Lucas issued Order No. 24-UI-245326, affirming the December 8, 2023, WPBR. On January 18, 2024, ALJ Lucas issued Orders No. 24-UI-245808, 24-UI-245833, 24-UI-245825, and 24-UI-245822, respectively affirming each of the four PUA determinations. On January 30, 2024, claimant filed applications for review of Orders No. 24-UI-245808, 24-UI-245833, 24-UI-245825, 24-UI-245822, and 24-UI-245326 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 24-UI-245808, 24-UI-245833, 24-UI-245825, 24-UI-245822, and 24-UI-245326. For case-tracking purposes, this decision is being issued in quintuplicate (EAB Decisions 2024-EAB-0136, 2024-EAB-0139, 2024-EAB-0138, 2024-EAB-0137, and 2024-EAB-0135).

**WRITTEN ARGUMENT:** Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented him from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's argument to the extent it was based on the record.

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 24-UI-245808, 24-UI-245833, 24-UI-245825, 24-UI-245822, and 24-UI-245326 are affirmed.
