

EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0146

Affirmed
Requests to Reopen Allowed
Ineligible Weeks 36-23 through 40-23 and 45-23 through 47-23

PROCEDURAL HISTORY: On November 28, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work from September 3 through October 7, 2023 (weeks 36-23 through 40-23) and was ineligible for benefits for those weeks and until the reason for the denial ended (decision # 101153). Also on November 28, 2023, the Department served notice of an administrative decision concluding that claimant was not available for work from September 3 through October 7, 2023 (weeks 36-23 through 40-23) and November 5 through 25, 2023 (weeks 45-23 through 47-23) and was ineligible for benefits for those weeks and until the reason for the denial ended (decision # 94435). Claimant filed timely requests for hearing on decisions # 101153 and 94435.

On December 12, 2023, notice was mailed to the parties that hearings were scheduled for December 26, 2023. On December 26, 2023, ALJ Blam convened hearings at which claimant failed to appear, and issued Orders No. 23-UI-244137 and 23-UI-244138, dismissing claimant's requests for hearing on decisions # 101153 and 94435 due to claimant's failure to appear. On December 29, 2023, claimant filed a timely request to reopen the December 26, 2023, hearings. On January 29, 2024, ALJ Blam conducted a hearing, and on February 6, 2024, issued Orders No. 24-UI-247458 and 24-UI-247459, allowing claimant's requests to reopen and affirming decisions # 101153 and 94435 on the merits. On February 9, 2024, claimant filed applications for review of Orders No. 24-UI-247458 and 24-UI-247459 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 24-UI-247458 and 24-UI-247459. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2024-EAB-0146 and 2024-EAB-0147).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 24-UI-247458 and 24-UI-247459 are affirmed.
