EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0160

Late Application for Review Dismissed

PROCEDURAL HISTORY: On June 16, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits beginning August 9, 2020, because he was fired by the employer for a disqualifying act (decision # 70107). On July 6, 2021, decision # 70107 became final without claimant having requested a hearing. On July 22, 2022, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on October 26, 2022, issued Order No. 22-UI-205903, dismissing the request as late without a showing of good cause, subject to claimant's right to renew the request by responding to an appellant questionnaire by November 9, 2022.

On November 5, 2022, claimant filed a timely response to the appellant questionnaire. On December 20, 2022, the Office of Administrative Hearings (OAH) mailed the parties a letter stating that based on claimant appellant questionnaire response, Order No. 22-UI-205903 was cancelled and vacated, and that a hearing would be scheduled on whether claimant's late request for hearing should be allowed and, if so, the merits of decision # 70107. On January 10, 2024, ALJ Janzen conducted the hearing, and on January 11, 2024, issued Order No. 24-UI-245350, re-dismissing claimant's request for hearing as late without good cause, leaving decision # 70107 undisturbed. On January 31, 2024, Order No. 24-UI-245350 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On February 7, 2024, claimant filed a late application for review with EAB.

FINDING OF FACT: Order No. 24-UI-245350, mailed to claimant on January 11, 2024, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 24-UI-245350 at 3. Order No. 24-UI-245350 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before January 31, 2024, to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 24-UI-245350 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR

471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 24-UI-245350 was due January 31, 2024. Because claimant did not file their application for review until February 7, 2024, the application for review was late. Claimant's application for review did not include a written statement describing circumstances preventing claimant from filing the application for review by the January 31, 2024, deadline. Accordingly, claimant did not show good cause for the late application for review, and the late application for review is dismissed.

DECISION: The application for review filed February 7, 2024, is dismissed. Order No. 24-UI-245350 remains undisturbed.
