EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0166

Late Application for Review Dismissed

PROCEDURAL HISTORY: On November 9, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged by the employer for misconduct and disqualified from receiving benefits effective July 30, 2023 (decision # 134945). Claimant filed a timely request for hearing. On December 18, 2023, ALJ Lucas conducted a hearing, and on December 19, 2023, issued Order No. 23-UI-243778, reversing decision # 134945 by concluding that claimant was discharged, but not for misconduct, and not disqualified from receiving benefits based on the work separation. On January 8, 2024, Order No. 23-UI-243778 became final without the employer having filed an application for review with the Employment Appeals Board (EAB). On February 14, 2024, the employer filed a late application for review with EAB.

FINDING OF FACT: (1) Order No. 23-UI-243778, mailed to the employer on December 19, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-243778 at 4. Order No. 23-UI-243778 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before January 8, 2024, to be timely."

CONCLUSIONS AND REASONS: The employer's late application for review of Order No. 23-UI-243778 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-243778 was due January 8, 2024. Because the employer did not file their application for review until February 14, 2024, the application for review was late. The employer's application for review did not include a written statement describing circumstances preventing them from filing the application for review by the January 8, 2024, deadline. Accordingly, the employer did not show good cause for the late application for review, and their late application for review is dismissed.

DECISION: The application for review filed February 14, 2024, is dismissed. Order No. 23-UI-243778 remains undisturbed.
