

EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0185

Affirmed
Request to Reopen Granted
No Disqualification

PROCEDURAL HISTORY: On August 15, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged by the employer for misconduct and disqualified from receiving unemployment insurance benefits effective June 11, 2023 (decision # 140713). Claimant filed a timely request for hearing. On August 25, 2023, the Office of Administrative Hearings (OAH) served notice that the hearing was scheduled for September 6, 2023. On September 6, 2023, claimant failed to appear at the hearing, and on September 8, 2023, ALJ Enyinnaya issued Order No. 23-UI-235450, dismissing claimant's request for hearing due to her failure to appear. Claimant filed a timely request to reopen the hearing. On January 10, 2024, OAH served notice that a hearing was scheduled for January 23, 2024 on whether to grant claimant's request to reopen and, if so, the merits of decision # 140713. On January 23, 2024, ALJ Wardlow conducted the hearing, and on January 26, 2024 issued Order No. 24-UI-246635, allowing claimant's request to reopen and reversing decision # 140713 by concluding that claimant was discharged, but not for misconduct, and that claimant was not disqualified from receiving benefits based on the work separation. The employer filed a timely application for review of Order No. 24-UI-246635 with the Employment Appeals Board (EAB).

EVIDENTIARY MATTER: On March 12, 2024, the employer submitted additional evidence for EAB to consider when reaching this decision. However, the employer did not establish that factors or circumstances beyond the employer's reasonable control prevented the employer from offering the additional evidence at the January 23, 2024 hearing, as required under OAR 471-041-0090(1)(b)(B) (May 13, 2019). EAB therefore did not consider the employer's additional evidence when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 24-UI-246635 is affirmed.
