EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0202

Affirmed
Late Request for Hearing Allowed;
Not Eligible for PUA Weeks 49-20 through 1-21

PROCEDURAL HISTORY: On October 12, 2021, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to PUA benefits effective December 6, 2020. On November 1, 2021, the October 12, 2021 PUA Determination became final with claimant having filed a request for hearing. On November 12, 2021 claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on March 2, 2022 issued Amended Order No. 22-UI-187689, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by March 16, 2022. Claimant filed a timely response to the appellant questionnaire.

On June 16, 2022, the Office of Administrative Hearings (OAH) mailed a letter stating that Amended Order No. 22-UI-187689 was vacated and that a new hearing would be scheduled to determine whether to allow claimant's late request for hearing and, if so, the merits of the October 12, 2021 PUA determination. On February 8, 2024, ALJ Chiller conducted the hearing, and on February 20, 2024 issued Order No. 24-UI-248405, allowing claimant's late request for hearing but affirming the October 12, 2021 PUA determination by concluding claimant was not eligible for PUA benefits from November 29, 2020 through January 9, 2021 (weeks 49-20 through 1-21). On February 23, 2024, claimant filed an application for review of Order No. 24-UI-248405 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered claimant's written argument when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 24-UI-248405 is affirmed.
