

**EMPLOYMENT APPEALS BOARD DECISION**  
**2024-EAB-0220**

*Affirmed*  
*Ineligible Weeks 49-23 through 52-23*

**PROCEDURAL HISTORY:** On December 20, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant had failed to register for work in accordance with the Department's rules and therefore was ineligible to receive unemployment insurance benefits for the week of December 3, 2023, through December 9, 2023 (week 49-23) and until the reason for the denial had ended. On December 21, 2023, the Department served notice of an administrative decision concluding that claimant had failed to provide information to the Department and was therefore ineligible for benefits for the weeks of December 3, 2023, through December 16, 2023 (weeks 49-23 through 50-23) and until the reason for the denial ended (decision # 112757). Claimant filed timely requests for hearing on both administrative decisions. On February 21, 2024, ALJ Logan conducted a consolidated hearing on both administrative decisions, at which the Department failed to appear. On February 22, 2024, ALJ Logan issued Orders No. 24-UI-248590 and 24-UI-248589, modifying the December 20, 2023, administrative decision and decision # 112757, respectively, by concluding that claimant was ineligible to receive benefits for the weeks of December 3, 2023, through December 30, 2023 (weeks 49-23 through 52-23). On February 27, 2024, claimant filed applications for review of with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 24-UI-248590 and 24-UI-248589. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2024-EAB-0220 and 2024-EAB-0219).

EAB considered the entire consolidated hearing record. EAB agrees with Orders No. 24-UI-248590 and 24-UI-248589's findings of fact, reasoning, and conclusions that claimant was ineligible to receive benefits for weeks 49-23 through 52-23 because she had failed to register for work, and because she had failed to provide information to the Department. Pursuant to ORS 657.275(2), Orders No. 24-UI-248590 and 24-UI-248589 are **adopted**.

**DECISION:** Orders No. 24-UI-248590 and 24-UI-248589 are affirmed.
