

EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0221

Affirmed
Disqualification

PROCEDURAL HISTORY: On November 1, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective October 1, 2023 (decision # 64505). On November 21, 2023, decision # 64505 became final without claimant having filed a request for hearing. On November 23, 2023, claimant filed a late request for hearing on decision # 64505.

ALJ Kangas considered claimant's request, and on December 6, 2023, issued Order No. 23-UI-242736, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by December 20, 2023. On December 15, 2023, claimant filed a timely response to the appellant questionnaire. On January 18, 2024, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 23-UI-242736 was vacated and that a hearing would be scheduled to determine whether claimant had good cause to file the late request for hearing and, if so, the merits of decision # 64505. On February 8, 2024, ALJ Janzen conducted a hearing at which the employer failed to appear, and on February 9, 2024, issued Order No. 24-UI-247708, concluding that claimant's request for hearing was late, but with good cause, and affirming decision # 64505 on the merits. On February 27, 2024, claimant filed an application for review of Order No. 24-UI-247708 with the Employment Appeals Board (EAB).

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-247708's findings of fact, reasoning, and conclusion that claimant's request for hearing was late, but with good cause, and that claimant quit work without good cause and is disqualified from benefits effective October 1, 2023. Pursuant to ORS 657.275(2), Order No. 24-UI-247708 is **adopted**.

DECISION: Order No. 24-UI-247708 is affirmed.
