EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0229

Application for Review Dismissed Without Prejudice

PROCEDURAL HISTORY AND FINDINGS OF FACT: On October 11, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide information in accordance with the Department's rules and was therefore ineligible to receive unemployment insurance benefits for the weeks of September 24, 2023 through October 7, 2023 (weeks 39-23 through 40-23) and until the reason for the denial ended (decision # 95414). On October 31, 2023, decision # 95414 became final without claimant having filed a request for hearing. On December 28, 2023, claimant filed a late request for hearing on decision # 95414. ALJ Kangas considered claimant's request, and on January 18, 2024, issued Order No. 24-UI-245927, dismissing claimant's request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by February 1, 2024. On February 7, 2024, Order No. 24-UI-245927 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On March 1, 2024, claimant filed a late application for review of Order No. 24-UI-245927 with EAB.

CONCLUSIONS AND REASONS: The application for review is dismissed without prejudice.

On March 1, 2024, the appellant filed an application for review of Order No. 24-UI-245927 with EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than February 7, 2024. The appellant's application for review is therefore late, and this application for review is dismissed.

The deadline for filing an application for review may be extended a reasonable time upon a showing of good cause. See ORS 657.875; OAR 471-041-0070 (May 13, 2019). If the appellant believes they have good cause and filed their late application for review within a reasonable time, the appellant may request that EAB reconsider this decision under OAR 471-041-0145 (May 13, 2019).

EAB will dismiss any request for reconsideration that does not include all five of the following:

1. The appellant (claimant) must file the request for reconsideration within 20 days of the date this decision was mailed; the date this decision was mailed is April 8, 2024, and

- 2. The appellant must include a statement on the request for reconsideration declaring that they sent a copy of the request to the other party, and
- 3. The appellant must provide additional specific details about the reason they filed a late application for review. For example, the appellant should include specific information about whether they received the ALJ's order (Order No. 24-UI-245927, issued January 18, 2024) and, if so, the date they received the ALJ's order, whether they read it, whether they agreed or disagreed with the ALJ's order, the reason(s) why they did not file the application for review before the February 7, 2024 deadline, how the reason(s) affected their ability to file a timely application for review, and any other specific details that might help EAB determine whether or not the appellant had "good cause," which means factors or circumstances beyond their reasonable control prevented them from filing a timely application for review, and
- 4. The appellant must provide the date the circumstances that prevented them from filing a timely application for review (which they listed in response to #3, above) ceased to exist, and
- 5. The appellant must provide sufficient information to prove that they filed their application for review within seven days of that date.

Further, if the appellant's request for reconsideration is allowed and their late application for review is allowed, the record currently contains insufficient information to determine that good cause exists to allow their late request for hearing on decision # 95414. Therefore, **the appellant should also provide specific details about the reason they filed their request for hearing on decision # 95414 (issued October 11, 2023) late.** For example, the appellant should include specific information about whether they received decision # 95414 and, if so, the date they received decision # 95414, whether they read it, the reason(s) why they did not file the request for hearing before the October 31, 2023 deadline, how the reason(s) affected their ability to file a timely request for hearing, and any other specific details that might help determine whether or not the appellant had "good cause," which means factors or circumstances beyond their reasonable control prevented them from filing a timely request for hearing. They should also provide the date the circumstances that prevented them from filing a timely request for hearing on decision # 95414 ceased to exist, and that they filed their late request for hearing within seven days of that date.

To clarify, the appellant should provide **two detailed explanations: one for why their application for review of Order No. 24-UI-245927 was filed late, and one for why their request for hearing on decision # 95414 was filed late.**

The appellant may file a request for reconsideration in many ways; please note that you need only file one request for reconsideration:

1. Use your smart phone, tablet, or computer to fill out the "File a Written Argument" form, available on EAB's website: https://www.oregon.gov/EMPLOY/EAB/Pages/default.aspx, or

- 2. Use your smart phone, tablet, or computer to send an email to EAB at OED_EAB_OFFICE@employ.oregon.gov, or

- 4. Send EAB a fax at 503-378-2129.

DECISION: The application for review filed March 1, 2024, is dismissed without prejudice. Order No. 24-UI-245927 remains undisturbed.
