

EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0233

Affirmed
Late Request to Reopen Denied

PROCEDURAL HISTORY: On August 25, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged by the employer for misconduct and disqualified from receiving benefits effective June 4, 2023 (decision # 141123). Claimant filed a timely request for hearing. On September 15, 2023, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for September 26, 2023. On September 26, 2023, claimant failed to appear at the hearing, and ALJ Lewis issued Order No. 23-UI-236818, dismissing claimant's request for hearing due to their failure to appear. On October 16, 2023, Order No. 23-UI-236818 became final without claimant having filed a request to reopen the hearing. On October 20, 2023, claimant filed a late request to reopen the hearing. ALJ Scott considered claimant's request, and on February 23, 2024, issued Order No. 24-UI-248704, denying the request as late without a showing of good cause, leaving Order No. 23-UI-236818 undisturbed. On March 1, 2024, claimant filed an application for review of Order No. 24-UI-248704 with the Employment Appeals Board (EAB).

EAB considered the entire record. EAB agrees with Order No. 24-UI-248704's findings of fact, reasoning, and conclusion that claimant's request to reopen the hearing is denied as late without a showing of good cause. Pursuant to ORS 657.275(2), Order No. 24-UI-248704 is **adopted**.

DECISION: Order No. 24-UI-248704 is affirmed.
