EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0236

Affirmed No Disqualification

PROCEDURAL HISTORY: On December 11, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged for misconduct, and therefore was disqualified from receiving unemployment insurance benefits effective September 17, 2023, but that claimant was not subject to cancellation of all rights to benefits based on wages earned prior to the work separation (decision # 143025). Claimant filed a timely request for hearing. On February 13, 2024, ALJ Christon conducted a hearing, and on February 20, 2024, issued Order No. 24-UI-248387, reversing decision # 143025 by concluding that claimant was discharged, but not for misconduct, and was not disqualified from receiving benefits based on the work separation. On March 4, 2024, the employer filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: The employer's argument contained information that was not part of the hearing record and did not show that factors or circumstances beyond the employer's reasonable control prevented them from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered the employer's argument to the extent it was based on the record.

In their written argument, the employer raised concerns about a finding of fact in the order under review, asserting,

". . . it states [claimant] was discharged for taking tickets from employer and giving them away and etc.

Taking tickets without permission is STEALING, which is a misconduct.

Employer's Written Argument at 1 (emphasis in original). The employer is correct that the record supports a finding that claimant took the tickets in question without first obtaining permission to do so.

However, claimant's actions did not constitute "theft" (the statutory term for "stealing") under the applicable laws in the state of Oregon. ORS 164.015 states,

A person commits theft when, with intent to deprive another of property or to appropriate property to the person or to a third person, the person:

(1) Takes, appropriates, obtains or withholds such property from an owner thereof[.]

* * *

(emphasis added). While it is clear from the record that claimant took tickets from the employer's front counter and gave them to an employee at a neighboring business without permission, the record also shows that claimant intended to talk to the owner of the theater that issued the tickets to try to "get [the other employee] a good deal" on the tickets. Transcript at 24. Additionally, the record shows that claimant was friends with the theater owner, spoke to him regularly, had arranged for similar "deals" for theater tickets before, and later paid the theater owner for the tickets in question. *See* Transcript at 29, 10. Based on these facts, it is reasonable to infer that claimant understood his actions to be acceptable by the theater owner (to whom the tickets belonged at the time), and that he likewise intended the theater owner to either be compensated for the tickets, or else to offer them on a complimentary basis. The record therefore does not show that claimant intended to deprive the theater owner of his property, and claimant's decision to take them without first obtaining permission was, as a result, not "theft."

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-248387's findings of fact, reasoning, and conclusion that claimant was discharged, but not for misconduct. Pursuant to ORS 657.275(2), Order No. 24-UI-248387 is **adopted**.

DECISION: Order No. 24-UI-248387 is affirmed.
