# EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0240

*Affirmed Benefits Not Payable During the School Recess Period* 

**PROCEDURAL HISTORY:** On January 23, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied unemployment insurance benefits from December 24, 2023 through January 13, 2024 (weeks 52-23 through 02-24), during a school recess period, because he was likely to return to work for the employer after the break, and his wages and/or hours with non-educational employers were not sufficient to entitle him to benefits during the break (decision # 84324). Claimant filed a timely request for hearing. On February 14, 2024, ALJ Frank conducted a hearing at which the employer failed to appear, and on February 22, 2024, issued Order No. 24-UI-248618, modifying decision # 84324 by concluding that claimant was denied benefits from December 24, 2023 through January 6, 2024 (weeks 52-23 through 01-24),<sup>1</sup> during a school recess period, because he was likely to return to work for the employer after the break, and his wages and/or hours with non-educational employers were not sufficient to entitle him to benefits from December 24, 2023 through January 6, 2024 (weeks 52-23 through 01-24),<sup>1</sup> during a school recess period, because he was likely to return to work for the employer after the break, and his wages and/or hours with non-educational employers were not sufficient to entitle him to benefits during the break. On March 5, 2024, claimant filed an application for review with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** EAB did not consider claimant's written argument when reaching this decision because he did not include a statement declaring that he provided a copy of his argument to the opposing party as required by OAR 471-041-0080(2)(a) (May 13, 2019).

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-248618's findings of fact, reasoning, and conclusion that claimant was denied benefits for weeks 52-23 through 01-24, during a school recess period, because he was likely to return to work for the employer after the break, and his wages and/or hours with non-educational employers were not sufficient to entitle him to benefits during the break. Pursuant to ORS 657.275(2), Order No. 24-UI-248618 is **adopted**.

DECISION: Order No. 24-UI-248618 is affirmed.
