

EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0245

Affirmed
Requests to Reopen Allowed
Disqualification

PROCEDURAL HISTORY: On April 9, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective June 21, 2020 (decision # 74702). Claimant filed a timely request for hearing. On December 1, 2022, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for December 13, 2022. On December 13, 2022, claimant failed to appear at the hearing, and ALJ Vaughn issued Order No. 22-UI-209723, dismissing claimant's request for hearing due to her failure to appear. On December 27, 2022, claimant filed a timely request to reopen the hearing. On September 8, 2023, OAH served notice of a hearing scheduled for September 20, 2023. On September 20, 2023, claimant failed to appear at the hearing, and on September 21, 2023, ALJ Lucas issued Order No. 23-UI-236401, denying claimant's request to reopen based on her failure to appear for the September 20, 2023, hearing, leaving Order No. 22-UI-209723 undisturbed.

On October 10, 2023, claimant filed a timely request to reopen the September 20, 2023, hearing. On October 13, 2023, OAH served notice of a hearing scheduled for October 26, 2023. On October 26, 2023, claimant failed to appear at the hearing, and on November 2, 2023, ALJ Lucas issued Order No. 23-UI-240159, denying claimant's request to reopen based on her failure to appear for the October 26, 2023, hearing, leaving Order No. 23-UI-236401 undisturbed. On November 10, 2023, claimant filed a timely request to reopen the October 26, 2023, hearing. On February 26, 2024, ALJ Lucas conducted a hearing, and on March 4, 2024, issued Order No. 24-UI-249351, allowing claimant's requests to reopen, but affirming decision # 74702 on the merits. On March 7, 2024, claimant filed an application for review of Order No. 24-UI-249351 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB did not consider claimant's written argument when reaching this decision because she did not include a statement declaring that she provided a copy of her argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019).

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-249351’s findings of fact, reasoning, and conclusions that claimant’s requests to reopen should be allowed, and that claimant quit working for the employer without good cause. Pursuant to ORS 657.275(2), Order No. 24-UI-249351 is **adopted**.

DECISION: Order No. 24-UI-249351 is affirmed.
