**EMPLOYMENT APPEALS BOARD DECISION**  
**2024-EAB-0246**

*Affirmed*  
*Late Request for Hearing Dismissed*

**PROCEDURAL HISTORY:** On July 12, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits beginning June 4, 2023, because he was fired by the employer for misconduct (decision # 141105). On August 1, 2023, decision # 141105 became final without claimant having filed a request for hearing. On August 3, 2023, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on December 13, 2023, issued Order No. 23-UI-243300, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by December 27, 2023. On December 19, 2023, claimant filed a timely response to the appellant questionnaire. ALJ Scott considered claimant's response, and on February 21, 2024, issued Order No. 24-UI-248484, canceling Order No. 23-UI-243300 and re-dismissing claimant's request for hearing as late without a showing of good cause, leaving decision # 141105 undisturbed. On March 5, 2024, claimant filed an application for review with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** EAB did not consider claimant's written argument when reaching this decision because he did not include a statement declaring that he provided a copy of his argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019).

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-248484's findings of fact, reasoning, and dismissal of claimant's request for hearing as late without a showing of good cause, leaving on decision # 141105 undisturbed. Pursuant to ORS 657.275(2), Order No. 24-UI-248484 is **adopted**.

**DECISION:** Order No. 24-UI-248484 is affirmed.
