

EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0249

Affirmed
Disqualification

PROCEDURAL HISTORY: On January 9, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was fired by the employer, but not for misconduct, and was not disqualified from receiving benefits based on the work separation (decision # 172508). The employer filed a timely request for hearing. On February 27, 2024, ALJ Chiller conducted a hearing at which claimant failed to appear, and on February 28, 2024, issued Order No. 24-UI-249095, reversing decision # 172508 by concluding that the employer discharged claimant for misconduct, disqualifying claimant from receiving benefits effective August 6, 2023. On March 6, 2024, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-249095's findings of fact, reasoning, and conclusion that the employer discharged claimant for misconduct, disqualifying claimant from receiving benefits effective August 6, 2023. Pursuant to ORS 657.275(2), Order No. 24-UI-249095 is **adopted**.

DECISION: Order No. 24-UI-249095 is affirmed.
