

EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0252

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On February 21, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was disqualified from receiving unemployment insurance benefits effective January 22, 2023 (decision # 111818). Claimant filed a timely request for hearing.

On May 10, 2023, the Office of Administrative Hearings (OAH) served notice of a hearing on decision # 111818 scheduled for May 24, 2023, at 1:30 p.m. On May 24, 2023, claimant failed to appear for the hearing, and ALJ Scott issued Order No. 23-UI-226017, dismissing the hearing request on decision # 111818 due to claimant's failure to appear and leaving the administrative decision undisturbed. On June 1, 2023, claimant filed a timely request to reopen the May 24, 2023, hearing. ALJ Kangas considered claimant's request, and on February 8, 2024, issued Order No. 24-UI-247607, denying claimant's request to reopen the hearing and leaving Order No. 23-UI-226017 undisturbed. On February 25, 2024, claimant filed an application for review of Order No. 24-UI-247607 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB did not consider claimant's written argument when reaching this decision because they did not include a statement declaring that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019).

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-247607's findings of fact, reasoning, and conclusion that claimant did not have good cause for failing to appear at the hearing and therefore their request to reopen is denied. Pursuant to ORS 657.275(2), Order No. 24-UI-247607 is **adopted**.

DECISION: Order No. 24-UI-247607 is affirmed.
