EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0267

Affirmed Disqualification

PROCEDURAL HISTORY: On February 6, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged for misconduct and was therefore disqualified from receiving unemployment insurance benefits effective November 26, 2023 (decision # 131428). Claimant filed a timely request for hearing. On February 27, 2024, ALJ Contreras conducted a hearing at which the employer failed to appear, and on February 29, 2024, issued Order No. 24-UI-249178, affirming decision # 131428. On March 15, 2024, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's argument to the extent it was based on the record.¹

Claimant contended that the new information, a letter from the patient whose medical records claimant accessed for personal reasons, should be considered on appeal because claimant "didn't realize [she] had [the] option" to call witnesses at the hearing. Claimant's Argument at 3. The Notice of Rights attached to the hearing notice, which was mailed to claimant on February 14, 2024, stated, "If you have witnesses you want to testify at the hearing, at the beginning of the hearing tell the ALJ the names and telephone numbers of your witnesses." Notice of Rights at 1. Claimant's failure to read the notice explaining her rights prior to the hearing was not a factor or circumstance beyond her reasonable control that prevented her from calling her witness and eliciting as testimony the information that is now contained in the letter. Therefore, OAR 471-041-0090 precludes EAB's consideration of that letter.

¹ Claimant filed a written argument with her application for review which did not contain a statement that a copy of it had been served on the other party. However, claimant re-filed this argument in essentially identical form with the required statement on March 19, 2024, and all references herein to her written argument are made with respect to the March 19, 2024, filing only.

Moreover, even without the letter, the record contains claimant's testimony that the patient had authorized claimant to access his records on occasions prior to the incident for which she was discharged. Audio Record at 14:39 to 15:25. However, claimant accessed the patient's records on those occasions for business or medical purposes, such as scheduling appointments or printing a visit note that the patient requested. Audio Record at 14:39 to 15:25. When claimant accessed his records for the final time, "about a month" after she and the patient ceased being romantic partners, she did so "because he had been involved in a shooting and out of extreme concern, [she] just needed to know if he was going to be alright." Audio Record at 11:50 to 12:20. Had the information in the letter been part of the record, it still would not have changed the fact that claimant accessed the patient's medical record on the final occasion without a business or medical purpose, and only for claimant's personal reasons. Even if the patient did not later object to claimant having accessed his records for this purpose, her actions, more likely than not, violated HIPAA and the employer's reasonable policies which prohibited accessing patient records without a business or medical purpose. The record shows that claimant knew or should have known from her approximately seven years of experience working for the employer that her actions would likely violate the employer's reasonable expectations, and further shows that she was indifferent to the consequences. Accordingly, consideration of the new information offered by claimant would not have affected the outcome of this decision.

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-249178's findings of fact, reasoning, and conclusion that claimant was discharged for misconduct. Pursuant to ORS 657.275(2), Order No. 24-UI-249178 is **adopted**.

DECISION: Order No. 24-UI-249178 is affirmed.
