

**EMPLOYMENT APPEALS BOARD DECISION**  
**2024-EAB-0274**

*Affirmed*  
*Disqualification*

**PROCEDURAL HISTORY:** On December 4, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective June 4, 2023 (decision # 153818). Claimant filed a timely request for hearing. On January 30 and February 22, 2024, ALJ Blam conducted a hearing, and on March 1, 2024, issued Order No. 24-UI-249292, affirming decision # 153818.<sup>1</sup> On March 15, 2024, claimant filed an application for review with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** Claimant did not declare that he provided a copy of his argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented him from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

The above notwithstanding, claimant asserted in his written argument that the hearing proceedings were unfair or the ALJ was biased. *See* Claimant's Written Argument at 2. EAB reviewed the hearing record in its entirety, which shows that the ALJ inquired fully into the matters at issue and gave all parties reasonable opportunity for a fair hearing as required by ORS 657.270(3) and (4) and OAR 471-040-0025(1) (August 1, 2004).

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-249292's findings of fact, reasoning, and conclusion that claimant quit work without good cause. Pursuant to ORS 657.275(2), Order No. 24-UI-249292 is **adopted**.

<sup>1</sup> The order under review concluded that claimant was disqualified from receiving benefits effective December 3, 2023. Order No. 24-UI-249292 at 3. The order under review found, however, that claimant quit work on June 6, 2023. 24-UI-249292 at 1. Therefore, the date of disqualification in the order under review appears to be scrivener's error, and EAB presumes the order intended to affirm decision # 153818's June 4, 2023, disqualification date.

**DECISION:** Order No. 24-UI-249292 is affirmed.
