EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0276

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On October 19, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not able to work from September 18 through October 8, 2022, and was denied benefits for that period and until the reason for the denial ended (decision # 111037). Claimant filed a timely request for hearing. On January 9, 2024, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for January 23, 2024. On January 23, 2024, claimant failed to appear at the hearing, and ALJ Frank issued Order No. 24-UI-246291, dismissing claimant's request for hearing due to their failure to appear. On February 5, 2024, claimant filed a timely request to reopen the hearing. ALJ Kangas considered claimant's request, and on March 7, 2024, issued Order No. 24-UI-249652, denying the request and leaving Order No. 24-UI-246291 undisturbed. On March 16, 2024, claimant filed an application for review of Order No. 24-UI-249652 with the Employment Appeals Board (EAB).

EAB considered the entire record. EAB agrees with Order No. 24-UI-249652's findings of fact, reasoning, and conclusion that claimant's request to reopen the hearing is denied, leaving Order No. 24-UI-246291 undisturbed. Pursuant to ORS 657.275(2), Order No. 24-UI-249652 is **adopted**.

DECISION: Order No. 24-UI-249652 is affirmed.
