

EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0281

Affirmed
Disqualification

PROCEDURAL HISTORY: On February 1, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective November 26, 2023 (decision # 125850). Claimant filed a timely request for hearing. On March 1, 2024, ALJ Janzen conducted a hearing, and on March 5, 2024, issued Order No. 24-UI-249434, affirming decision # 125850. On March 18, 2024, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant did not declare that he provided a copy of his argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented him from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-249434's findings of fact, reasoning, and conclusion that claimant quit working for the employer without good cause. Pursuant to ORS 657.275(2), Order No. 24-UI-249434 is **adopted**.

DECISION: Order No. 24-UI-249434 is affirmed.
