

EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0283

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On February 24, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged by the employer for misconduct and disqualified from receiving benefits effective February 5, 2023 (decision # 123839). Claimant filed a timely request for hearing. On April 18, 2023, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for May 2, 2023. On May 2, 2023, ALJ Messecar conducted a hearing at which the employer did not appear, and on May 10, 2023, issued Order No. 23-UI-224476, reversing decision # 123839 by concluding that the employer discharged claimant, but not for misconduct, and claimant was not disqualified from receiving benefits based on the work separation. On May 30, 2023, the employer filed a request to reopen the May 2, 2023, hearing. ALJ Scott considered the employer's request, and on February 7, 2024, issued Order No. 24-UI-247590, denying the request and leaving Order No. 23-UI-224476 undisturbed. On February 27, 2024, employer filed an application for review of Order No. 24-UI-247590 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: The employer did not declare that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the record, and did not show that factors or circumstances beyond the employer's reasonable control prevented them from offering the information with their request to reopen the hearing as required by OAR 471-040-0040(3) (February 10, 2012). Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into the record when reaching this decision.

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-247590's findings of fact, reasoning, and conclusion denying the employer's request to reopen the May 2, 2023, hearing. Pursuant to ORS 657.275(2), Order No. UI-24-UI-247590 is **adopted**.

DECISION: Order No. 24-UI-247590 is affirmed.
