

EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0288

Late Application for Review Dismissed

PROCEDURAL HISTORY: On December 4, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective August 27, 2023 (decision # 64815). Claimant filed a timely request for hearing. On February 8, 2024, ALJ Lucas conducted a hearing at which the employer did not attend, and on February 14, 2024, issued Amended Order No. 24-UI-248006, affirming decision # 64815. On March 5, 2024, Amended Order No. 24-UI-248006 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On March 20, 2024, claimant filed a late application for review with EAB.

FINDING OF FACT: Amended Order No. 24-UI-248006, mailed to claimant on February 14, 2024, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed.” Amended Order No. 24-UI-248006 at 3. Amended Order No. 24-UI-248006 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before March 5, 2024, to be timely.”

CONCLUSIONS AND REASONS: Claimant’s late application for review of Amended Order No. 24-UI-248006 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Amended Order No. 24-UI-248006 was due March 5, 2024. Because claimant did not file their application for review until March 20, 2024, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented claimant from filing the application for review by the March 5, 2024, deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed March 20, 2024, is dismissed. Amended Order No. 24-UI-248006 remains undisturbed.
