

EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0290

Affirmed
Ineligible Weeks 52-23 through 3-24

PROCEDURAL HISTORY: On January 11, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and was ineligible for benefits for the week of December 24 through 30, 2023 and until the reason for the denial ended. Claimant filed a timely request for hearing. On February 28, 2024, ALJ Chiller conducted a hearing, and on March 8, 2024, issued Order No. 24-UI-249748, modifying¹ the January 11, 2024, decision by concluding that claimant was not eligible for benefits for the weeks from December 24, 2023, through January 20, 2024. On March 21, 2024, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-249748's findings of fact, reasoning, and conclusion that claimant failed to register for work in accordance with the Department's rules and was ineligible for benefits for the weeks from December 24, 2023, through January 20, 2024. Pursuant to ORS 657.275(2), Order No. 24-UI-249748 is **adopted**.

DECISION: Order No. 24-UI-249748 is affirmed.
