

EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0293

Affirmed
No Disqualification

PROCEDURAL HISTORY: On December 4, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharge by the employer, but not for misconduct, and not disqualified from receiving benefits based on the work separation (decision # 74032). The employer filed a timely request for hearing. On December 27, 2023, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for January 9, 2024. On January 9, 2024, the employer failed to appear at the hearing, and ALJ Amesbury issued Order No. 24-UI-245111, dismissing the employer's request for hearing due to their failure to appear. On January 25, 2024, the employer filed a timely request to reopen the hearing. On March 7, 2024, ALJ Chiller conducted a hearing, and on March 12, 2024, issued Order No. 24-UI-249873, allowing the employer's request to reopen, cancelling Order No. 24-UI-245111,¹ but affirming decision # 74032 on the merits. On March 21, 2024, the employer filed an application for review of Order No. 24-UI-249873 with the Employment Appeals Board (EAB).

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-249873's findings of fact, reasoning, and conclusions that the employer's request for a reopening was allowed, and that the employer discharged claimant, but not for misconduct. Pursuant to ORS 657.275(2), Order No. 24-UI-249873 is **adopted**.

DECISION: Order No. 24-UI-249873 is affirmed.

¹ Order No. 24-UI-249873 concluded good cause for reopening the hearing had been shown and purported to cancel Order No. 2023-UI-03324. It is presumed this is a scrivener's error intending to cancel Order No. 24-UI-245111, which dismissed the employer's original request for hearing for failure to appear at the January 9, 2024 hearing. The reference to 2023-UI-03324 is the case number at OAH.
