

**EMPLOYMENT APPEALS BOARD DECISION**  
**2024-EAB-0301**

*Affirmed*  
*Ineligible Weeks 46-23 through 52-23*

**PROCEDURAL HISTORY:** On January 12, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not actively seeking work during the weeks of December 10, 2023, through December 30, 2023 (weeks 50-23 through 52-23) and was therefore ineligible to receive unemployment insurance benefits during those weeks (decision # 130236). Also on January 12, 2024, the Department served notice of an administrative decision concluding that claimant filed a late claim for unemployment insurance benefits for the weeks including November 12, 2023, through December 16, 2023 (weeks 46-23 through 50-23) and therefore was denied benefits for those weeks (decision # 131508). Claimant filed timely requests for hearing on both decisions. On February 20, 2024, and continuing on March 5, 2024, ALJ Goodrich conducted a consolidated hearing, and on March 7, 2024, issued Orders No. 24-UI-249658 and 24-UI-249661, affirming decisions # 130236 and 131508, respectively. On March 25, 2024, claimant filed applications for review of Orders No. 24-UI-249658 and 24-UI-249661 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 24-UI-249658 and 24-UI-249661. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2024-EAB-0300 and 2024-EAB-0301).

EAB considered the entire consolidated hearing record. EAB agrees with Orders No. 24-UI-249658 and 24-UI-249661's findings of fact, reasoning, and conclusions that claimant was not actively seeking work during weeks 50-23 through 52-23 and filed late benefit claims for weeks 46-23 through 50-23. Pursuant to ORS 657.275(2), Orders No. 24-UI-249658 and 24-UI-249661 are **adopted**.

**DECISION:** Orders No. 24-UI-249658 and 24-UI-249661 are affirmed.
