

**EMPLOYMENT APPEALS BOARD DECISION**  
**2024-EAB-0307**

*Affirmed*  
*Late Requests to Reopen Denied*

**PROCEDURAL HISTORY:** On July 23, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit working for the employer without good cause and was disqualified from receiving benefits effective November 29, 2020 (decision # 115905). On August 12, 2021, decision # 115905 became final without claimant having filed a request for hearing. On July 21, 2022, the Department served notice of an administrative decision based partly on decision # 115905, concluding that claimant received \$7,304 in Pandemic Emergency Unemployment Compensation (PEUC) and \$6,000 in Federal Pandemic Unemployment Compensation (FPUC) benefits to which they were not entitled and must repay (decision # 143926).

On August 8, 2022, claimant filed a late request for hearing on decision # 115905 and a timely request for hearing on decision # 143926. On May 17, 2023, the Office of Administrative Hearings (OAH) served notice of hearings scheduled for May 31, 2023, regarding decisions # 115905 and 143926. On May 31, 2023, claimant failed to appear at the hearings, and ALJ Lewis issued Orders No. 23-UI-226559 and 23-UI-226558, dismissing claimant's requests for hearing due to their failure to appear.

On June 20, 2023, Orders No. 23-UI-226559 and 23-UI-226558 became final without claimant having filed requests to reopen the hearings. On July 14, 2023, claimant filed late requests to reopen the hearings. ALJ Scott considered claimant's requests, and on March 7, 2024, issued Orders No. 24-UI-249656 and 24-UI-249655, denying the requests as late without good cause, leaving Orders No. 23-UI-226559 and 23-UI-226558 undisturbed.

On March 25, 2024, claimant filed applications for review of Orders No. 24-UI-249656 and 24-UI-249655 with the Employment Appeals Board (EAB). Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 24-UI-249656 and 24-UI-249655. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2024-EAB-0306 and 2024-EAB-0307).

EAB considered the entire consolidated record. EAB agrees with Orders No. 24-UI-249656's and 24-UI-249655's findings of fact, reasoning, and conclusions that claimant's requests to reopen the May 31,

2023, hearings are denied, leaving Orders No. 23-UI-226559 and 23-UI-226558 undisturbed. Pursuant to ORS 657.275(2), Orders No. 24-UI-249656 and 24-UI-249655 are **adopted**.

**DECISION:** Orders No. 24-UI-249656 and 24-UI-249655 are affirmed.
